The Council of Harvey Rural Community, under the authority vested in it by the Local Governance Act hereby enacts as follows:

PURPOSE: A By-law of Harvey Rural Community, in the Province of New Brunswick, for the purpose of establishing the remuneration of the Council for Harvey Rural Community.

WHEREAS: The enactment of this By-law #2025-07 repeals the following by-law(s); By-law # 2023-06 of Harvey Rural Community

1. REMUNERATION OF THE COUNCIL

- 1.01 The Mayor, Deputy Mayor, and each Councillor shall be paid an annual salary as outlined in the Annual Council Salary Table (Section 2).
- 1.02 The Mayor, Deputy Mayor, and each Councillor shall be reimbursed for expenses incurred while conducting Council business, in accordance with the rates set out in Appendix A of the Government of New Brunswick Travel Expenses Policy.
- 1.03 An Expense Claim Form must be submitted to the Municipal Treasurer to receive reimbursement.
- 1.04 Payment of salaries shall be made in equal quarterly installments.
- 1.05 Reimbursable expenses shall be paid on a monthly basis.
- 1.06 The Annual Council Salary Table (Section 2) shall be adjusted annually to reflect changes in the Consumer Price Index (CPI).
- 1.07 Effective with the commencement of the 2029 salary rates, those rates shall remain in effect in perpetuity and be adjusted annually thereafter to reflect changes in the Consumer Price Index (CPI).
